I am directed to refer to State Government letter No. FEE130FLL2022 (e) dated 09.10.2023 on the subject mentioned above. In this regard, it is informed that on examination of the additional information furnished by the State Government, it is observed that the name of the user agency has not been changed in FORM -A of the proposal i.e. as MoRTH/Central Government as per Ministry guidelines dated No. FC-11/50/2020-FC dated 18/08/2020. Further, as per the satellite imagery, it is seen that some advance work for planting has been carried out in degraded forest land identified to an extent of 22 ha in Haniya village, Huncha Hobli, Hosanagara Taluk, Shivamogga Division. Therefore, it may be clarified whether, in the said degraded forest land, any CA work has been carried out in *lieu* of any other forest diversion proposal or any other plantation activity has/is been undertaken. It may also be clarified if the area identified for raising CA is suitable for planting, as per para 2.4 (vii) of Chapter 2 of Handbook of Forest Conservation Act, 1980, (as per the DSS report, majority of the CA area identified comes under moderately dense forests).

In view of the above, it is requested to provide above mentioned information at the earliest to this office for further processing the proposal please.
