Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of **6.48 ha** of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above-mentioned proposal of the Govt of J&K in the  $2^{pd}$  REC meeting, the following information/clarification are still required to be submitted:

- i. Legal status of the proposal is submitted as Central Government whereas it should be state government/UT administration.
- ii. Employment generation details appear erroneous. Correct details to be furnish for the same;

- Muck disposal area is not clear in the proposal, somewhere in the proposal it is given 1.68 h but as per Column B-2.4, Part-I, it is 0.48 ha. Clarification/correction to be done.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.
