- (ii) The diverted area is mentioned as 5.00Ha in PART-I of Form A-1 Viii, B-2.1 and B2.2 instead of 2.91Ha. So proper justification required for the area mentioned.

- (iii) The KML file of CA land shows 10.00Ha, This should be verified.
- (iv) The letter which is given by the District Collector, Dharmapuri for no alternate route available found repeated in additional information details S.No.11
