FP/UK/ROAD/13065/2015 EDS dated: 25.04.2017 Construction of Kaphli - Kameda Motor Road (11.25 Km) from Kapkot Pindari Glacier MR (6.287 ha)

The reply of this office EDS dated 26.12.2016 has been submitted by the Addl. PCCF & Nodal Officer vide letter dated 21.03.2017 uploaded on 22.03.2017. Some shortcomings still remain in the reply/proposal which are given below:-

- 1. In reply to point no. 2 of EDS, the geo referenced digital map for the forest land proposed for diversion has been uploaded but the original hard copy has not been submitted for placing in the hard copy of the proposal.
- In reply to point no.3 of EDS, the geo referenced digital map for the area proposed for CA has been uploaded but the original hard copy has not been submitted for placing in the hard copy of the proposal.
- 3. In reply to point no.4 of EDS, it is mentioned that revised NPV calculation has been uploaded in online Part-II and also enclosed with the reply but this document has neither been found uploaded nor attached with the reply.
- 4. In reply to point no.6 of EDS, it is mentioned that the component wise breakup has been corrected and uploaded at para-B-2.3 of online Part-I but no correction has been found at para-B-2.3.
- 5. In reply to point no.7 of EDS, it is mentioned that the ownership proof of proposed CA land has been uploaded at para-L (iv) (g) of online Part-I but there is no para-L (iv) (g) in the online Part-I. Moreover, this document has not been found uploaded at any other sub para of para-L.
- 6. In reply to point no.8 of EDS, it is mentioned that the Cost Benefit Analysis has been uploaded at section-G in Part-II online but there is no section-G in Part-II online. Moreover, the Cost Benefit Analysis as per prescribed formats i.e. Annexure-VI (b) and Annexure-VI (c) has not been found uploaded at para-G of Part-I online.
- 7. State Govt. has not submitted the information about length & width of road passing through Van Panchayat Land, Civil Land & Naap Land separately including the land involved which is required for verification of area proposed for diversion.
- 8. No action has been taken on point no.5 of EDS. State Govt. has to submit either original or attested photocopies of all the documents to be placed in the hard copy of the proposal except geo referenced maps, FRA certificate & enumeration list of trees required to be submitted in original.
- 9. Taking 324 no. of saplings falling in diameter class of 0-10 cm into consideration, the total no. of trees per hectare comes to 139 trees. Therefore, the density which is mentioned at 0.2, is required to be reviewed by the State Government.

State Govt. is requested to remove above shortcomings and submit revised information/documents/clarifications.
