In the context of subject and reference mentioned above, you are requested to address the issue of Compensatory Afforestation, relevant to Gourangdih ABC Coal Mine project, in totality covering the related aspects like suitability Certificate for Compensatory Afforestation (CA), the Non-forest CA land being free from all legal encumbrances or any other similar issue highlighted in MoEF & CC's letter under reference (i).

For your ready reference the provisions related to Compensatory Afforestation in the Handbook of Guideline issued by MoEF & CC, Government of India are also enclosed herewith.

Your desired input shall reach to the undersigned through your CCF along with his comments.

Sub: Diversion of 109.459 ha of forest land for Open Cast Mining Project at Gourangdih ABC coal mine in favour of WB Mineral Development and Trading Corporation under Durgapur Forest Division, West Bengal.

Sir,

I am directed to refer to the State Government's letter letter No. 307-For/O/L/10T-01/2019 dated 03.03.2021 furnishing their response on Ministry's letter of even number dated 15.07.2019 towards instant proposal. The compliance report has been examined in consultation with DSS Cell of this Division of the Ministry and it is noted that still complete information has not submitted by the State government for further processing of the proposal for appropriate decision at Ministry level. It is further requested to submit complete report /information on following points.

1. From the perusal and analysis of the KML files submitted by the State Government it is observed that some Non-forestry activity/ mining in the proposed Forest land has been noticed on the eastern boundary of Gourangdih 'C' Coal block. It is also observed through DSS tool that many forest patches specifically in the Gourangdih 'C' Coal block boundary in the proposed area of diversion has not been included. In this regard, Maps are enclosed for your ready reference [Annexure-I (a to d)].

2. Ministry vide its letter of even number dated 15.07.2019 has requested to revise the proposed CA sites proposed on Plot Nos. 281, 1580, 306 & 358 which are falling on the Forest compartment boundaries instead of non-forest Govt. land as mentioned in the proposal and the encroachment in the form of agricultural land is also observed through Google earth Imagery dated 4/1/2019 in the proposed CA patches bearing Plot Nos. 253, 1863, 73, 48, 1840 & 1841". In its compliance the state government has not changed the CA sites. The discrepancies in proposed CA are reiterated as under:

a. Survey No/Khata No. 525, 306, 358, 3, 281 1580 and 1300 are falling in the Forest compartment.

b. Survey No/Khata No. 1152 is having some Settlements.

c. Survey No/Khata No. 561 (8.21 Ha) is having pre- plantation work.
 The copies of relevant Maps are enclosed for your ready reference [Annexure-II (a to e)].

3.It is reported by the Govt. of West Bengal that "there is no Mine adjacent to the Gourangdih 'ABC' Coal Project" whereas the IRO, Bhubaneswar in the Site Inspection Report reported that "on the eastern most side Gourangdih-'C' shares boundary with Gourangdih-'D' block, allocated to Eastern Coalfields Ltd". Thus, these contradictory information need clarification from the State Govt. and Integrated Regional Office for appropriate decision.

4. The conditional transfer of CA land in favour of Forest Department as approved by the Govt. of West Bengal vide their Memos No.1136-GE(M)/2L-358/17 dated 29.03.2018,No.1137-GE(M)/2L-13/18 dated 29.03.2018 and No.2232-GE(M)/2L-358/17 dated 22.06.2018 is not acceptable in accordance with provisions of FCA,1980 and guidelines thereof, as the equivalent non-forest land for compensatory afforestation has to be transferred and notified as RF/PF before Stage II approval.

5. The copy of minutes of the meeting wherein R&R plan approved is not given. Thus, the status of R& R plan is not clear.

In view of above, Govt. of West Bengal is requested to kindly review the proposal and CA sites with the help of DSS tool and submit with detailed clarification/ information/documents on the points indicated above for further consideration of the proposal.





Google Imagery dated 07.09.2015 showing the Non-forestry activity on the eastern boundary of Gourangdih 'C' Coal block





Google Imagery dated 06.11.2020 showing the Non-forestry activity on the eastern boundary of Gourangdih 'C' Coal block





DSS Map showing the presence of Forest land on the eastern boundary of Gourangdih 'C' Coal block








DSS Map Showing Part of Survey No/Khata No 03, 306, 525 and 358 are falling on the Forest compartment boundary
