Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the abovementioned subject seeking prior approval of the Central Government for diversion of 12.052 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

- After careful examination of the above-mentioned proposal of the Govt of J&K in the 2nd REC meeting, the following information/clarification are still required to be submitted:
 - Forest and non-forest area mentioned in Part-I column B 2.3 & 2.4 is erroneous. (i) This needs to be corrected.
 - In KML file the area of forest and non-forest patches are not clearly mentioned. (ii) The color of the KML file does not designate clearly between forest and non-forest patches. Therefore, portions in the forest and non-forest land are to be marked in different colors.
 - As some portions of road passing through non-forest area appears like forest area, (iii) the nodal officer was to constitute a joint team to visit such non-forest area on ground to submit an inspection report to the REC with respect to the apprehension raised by REC. The Joint Inspection Report be submitted.
