Subject: Proposed forest land (protected forest) diversion of 0.064318 ha for entry/exit of retail outlet of M/s Essar Oil Limited on plot no. 205/1 existing on Dhampur - Noorpur Road (MDR 03) in Noorpur Village of Chandpur Tehsil in District Bijnor without felling of trees-reg.

Sir,

In reference to your above mentioned letter where approval for above referred forest land diversion proposal was sought; I have been directed to convey following shortcomings of the proposal for necessary rectification:

1. Survey of India Topo sheet uploaded with proposal at C (iii) part I and with hard copy is Xerox copy not the original one.
2. The geo coordinates of curved portion of geo referenced map has not been provided in the proposal as per GIS DSS analysis.
3. Correction with whitener on Hindi version of part I (page 9) has been done without authentication.
4. The overlay of compensatory afforestation kml on Google Earth falls on existing road; which needs correction.
5. Site Inspection Report of DFO uploaded with part II does not clarify legal status of forest land proposed for diversion.
6. Site inspection report uploaded and in hard copy differs with each other.
7. The certificate provided by DM as per FRA 2006 does not clarify regarding rights of pre agricultural forest dwelling communities.
8. Part V of the proposal has not been uploaded.
9. A delay of approximate one month time has occurred from signing of part V by the concerned authority (26th October 2017) and signing of forwarding letter to Regional Office (21st November 2017) which is inexplicable. Reasons for this inordinate delay need submission.
10. Site suitability certificate for CA shall be uploaded with part II.
11. On several documents of the proposal name, date & seal of signing authority is missing.
