महोदय,

उपरोक्त विषयांकित पर संदर्भित पत्र का आशय ग्रहण करते हुए सूचित करना है कि राज्य सरकार द्वारा विन्दु संख्या 3,6,7 एवं 8 के सन्दर्भ में प्रस्तुत किये गए उत्तर त्रुटिपूर्ण पाए गए हैं। अतः राज्य सरकार उक्त विन्दुओं पर चाही गई सूचनाएं संपूर्ण रूप से प्रदान करने के साथ-साथ निम्नलिखित अतिरिक्त विन्दुओं पर भी सूचनाएँ प्रेषित करने का कष्ट करें, ताकि प्रस्ताव पर आगामी कार्यवाही सुनिश्चित की जा सके:-

- 1. Regarding observation no. 3, State Govt. has submitted that all consultations and meetings of FRC and Gram Sabha of concerned villages has been uploaded at Part-I, Para- K. However, Part- I, Para- K shows that only the FRC consultations and meetings has been uploaded at designated column. Therefore, State Govt. may provide/upload the following documents as well:
  - i. A copy of records of consultation and meetings of FRC of Sub Divisional Level Committee of Village Dharjol.
  - A copy of records of consultations and meetings of Gram Sabhas of concerned 05 villages.
- 2. In response to the observation no.6, it is submitted by the State Govt. that the 0.9049 ha non-forest land area has been included in the proposal and the sale deed /gift deed/affidavit in favour of HPPWD by the owners of private land holders has been uploaded against the additional information details in online Part-I. However, no documents in this regards has provided/uploaded on PARIVESH Portal. Therefore, State Govt. may provided/upload the same.

- Regarding observation no.7, State Govt. has submitted that dumping sites in the proposal has been proposed on private/non-forest land and the affidavit is this regards has been uploaded against additional information details in online Part-I. However, the following information has found missing in the respective observation:
  - i. Muck Management Plan (MMP) and detail of measurement of muck/debris to be generated in the project.
  - ii. The whole Khasra no. 493 and 322 situated at Muhal Dharjol/32 and Sandoa/223 respectively has been donated by the respective private land owners for dumping site, but how much area is being donated by the donors, from the said khasra nos., not clarified. Therefore same may be provided.
- 4. Regarding observation no. 8, State Govt. has submitted that to protect the soil erosion, Soil and Moisture Conservation Plan has been proposed. Therefore, as per the recent directions of MoEF & CC vide letter dated 07 June, 2022, Soil and Moisture Conservation Plan along with detail cost of its implementation into the account of CAMPA is required to be submitted along with Stage-I compliance. However, in cases where it is not possible for the State Govt. to submit the compliance due to delay in preparation of such plan, a lump sum amount of 0.5% of the project cost shall be realized from the User Agency and submitted along with the Stage-I compliance. The deficit amount, as per said plan, if any, from the money already realized to the tune of 0.5% of project cost shall be deposited in the CAMPA account prior to actual working on the forest area. An undertaking to this effect may also be submitted.
- 5. The proposed road completely covers all the beneficiary villages. However, KML file clearly shows that an another road is existing from geo-reference 31 43 27.87/76 44 39.06 to covering the area of village Dharjol and it leads from Dharjol village to down ward of South direction up to the proposed road of geo-reference 31 43 2.23/76 44 49.97. Therefore, State Govt. may provide the clarification whether the said existing road attracts the FCA provision? If yes, the whole proposal may needs to be reviewed and revised accordingly.

State Govt. shall ensure that all the desired information/documents are uploaded in designated column on Part-I/II of PARIVESH Portal.
