Sub: Proposal for diversion of 76.782 ha of forest land for widening and improvement of Yaingangpokpi-Nagaland Road Section of NH-202 into two laning with paved shoulder of 94.612 km from Longpi Kajuii to Chingjaroi Khullen of 129.100 km in the State of Manipur on EPC Mode by NHIDCL.

Sir.

With reference to the subject and letter cited above, I am directed to inform that the proposal submitted by the State Govt letter under reference above has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The submitted proposal is found lacking of the following information:

- (i) The clarification on density of the forest cover and eco class of the proposed area as it is mentioned as 25 % in the PART II whereas mentioned as 8% -35% in the forwarding letter.
- (ii) The Part V form is to be specifically mentioned as recommended or not.
- (iii) The existing and proposed ROW of the proposed road.
- (iv) The scientific names or atleast the local name of the tree species mentioned in 'other' category of the enumeration list specially the scientific name of the tree i.e. 'Ucham' having more than 8000 in nos.
- (v) The scheme for raising avenue plantation on both side of the road technically approved by the competent authority.
- (vi) The GPS coordinates of the proposed road.

- (vii) The undertaking certificate for addl. NPV by the user agency.
- (viii) The muck dumping plan of the proposed road.
- (ix) The undertaking by the user agency for payment for extraction charges of the trees to be removed from the proposed area.
- (x) The cost and benefit analysis along with cost and benefit ratio of the proposed area.

State Govt is requested to kindly furnish the above information for further processing of this proposal.
