
With reference to the subject and letter cited above, I am directed to inform that the proposal submitted by the State Govt letter under reference above has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The submitted proposal is found lacking of the following information:

- (i) The notification of Shirui National Park, if any, and actual distance of the proposed area from the Shirui National Park.
- (ii) The clarification on density of the forest cover and eco class of the proposed area as it is mentioned as 35 % in the PART II whereas mentioned as 8% -70% in the forwarding letter.
- (iii) The corrected shape file of the propose area as it is found to be 133.295 ha instead of 133.882 ha as proposed.
- (iv) The corrected shape file of the proposed CA site as it is found to be 218 ha instead of 268 ha as proposed.
- (v) The proposed RoW and existing RoW of the propose road.
- (vi) The scientific names or atleast the local name of the tree species mentioned in 'other' category of the enumeration list.
- (vii) The scheme for raising avenue plantation on both side of the road technically approved by the competent authority.
- (viii) The GPS coordinates of the proposed road.

- (ix) The undertaking certificate for addl. NPV by the user agency.
- (x) The muck dumping plan of the proposed road along with plan for vegetation/reclamation of the dumping site.
- (xi) The undertaking by the user agency for payment for extraction charges of the trees to be removed from the proposed area.
- (xii) The specific recommendation by the State Govt in Part V form.

State Govt is requested to kindly furnish the above information for further processing of this proposal.
