महोदय,


उपर्युक्त प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी है। अतः राज्य सरकार निम्नलिखित बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें, ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:-

- 1- Details of area proposed for muck disposal not filled at para B 2.4 in Part I online. State Govt. may provide the detail of the area proposed for muck dumping.
- 2- SoI toposheet of proposed road is not found uploaded. State Govt. may upload the SoI toposheet of the proposed road at para C (iii) in Part I.
- 3- Very few coordinates marked in the digital map of the proposed road and CA area. State Govt. may upload scanned copy of digital map providing geo coordinates at 200 to 300 m interval along the alignment of the proposed road including all turning points and location of dumping site may also be shown with the geo-coordinates. Geo coordinates at all the corner points of CA area may be shown.
- 4- Justification is not found uploaded. State Govt. may upload the justification for locating the project in the forest area.
- 5- 'Yes' is mentioned at para J in Part I related to scheduled area. State Govt. may submit the comments in this regard.
- 6- Name of CA area is not mentioned in the CA site suitability certificate. State Govt. may submit the CA site suitability certificate mentioning the name of the CA area.
- 7- Complete area falls in reserve forest land. Width of the road proposed in 9 m. DFO mentioned in his SIR that RoW can be taken in 6 m as this is only a link road to save the reserve forest area and trees. State Govt. not submitted any comments in this regard. State Govt. may review the same.

- 8- As per the norms of Indian Road Congress:52-2019, State Govt. is required to submit enumeration list of trees for 6.1 m width on turns and 5.2 m for rest of the alignment.
- 9- State Govt. may upload the work not start certificate duly authenticated by the DFO.
- 10- Blank NPV calculation sheet signed by Assistant Engineer, Executive Engineer and Range Forest Officer found uploaded in Part I. State Govt. may provide clarification for such casual approach in this regard and provide the NPV sheet.
- 11- State Govt. may upload the CA scheme online at para 13 in Part II.
- 12- It is noticed that documents uploaded online are not scanned properly. State Govt. may upload properly scanned documents of the proposal in Part I/II.
