3. CA KML file has been observed that the properties not showing in KML file. Rectification to be

need.

4. Gut No. wise starting points and ending points not showing in diverted area KML file.

5. As per area statement properties not showing in diverted area. Diverted area should be mentioned in properties of diverted KML file. Rectification to be needed.

- 6. The court cases no. C.R.M.P.No 571 of 2014 & 5/2019 is related to proposed area or not? If the said court cases is related to this proposed area the present status of the aforesaid court matter to be submitted.
- 7. The second POR No. POR/FIR No.E-1/2021-22, dated 27/04/2021 filled in court or not?. The status of the aforesaid POR should to be submitted.
- 8. The Original notification copy of the Reserved Forest and diverted area Gut No. clearly should be highlighted. The copy of the same to be provided.

9. How many command area is used by local villagers? Justification to be needed.

10. The said proposal is used for industrial purpose. please specify.

The above discrepancies should be complied to this office at the earliest.
