With reference to above subject, you have submitted online proposal in FORM-A, PART-1 for re-diversion of 2.469 ha. Forest land for construction of Toll Plaza with amenities for Up gradation of NH 66 between Goa-Karnataka Border-Kundapur Section (Formerly NH-17) in reference (1).

The proposal was submitted to the Additional Principal Chief Conservator of Forests (Forest Conservation) and Nodal Officer, Bangalore through Chief Conservator of Forests, Kanara Circle, Sirsi. The extent of forest land proposed for re-diversion has been revised from 2.469 hecatre to 1.449 hectare on the ground that 1.02 hectare of 2.469 hectare was disforested vide GOK Order No. AFD 262 FAF 70 dated 20-09-1970. However such crucial change requires necessary corrections to the following Items in PART-I of the proposal.

  - a) Item (iii), Item (viii) & (ix), B-2.1, B-2.2, B-2.3, B-2.4 Item C(ii)(a) KML File, C(iii) Topo Map, C(iv) Geo-referenced Map and also the GPS readings of the forest land proposed for diversion
