Undertakings/ Certificates to be furnished


1. Payment towards NPV & Additional NPV, if so determined as per final decision of Hon'ble Supreme Court of India.
2. Undertaking as regards the policy decision of the State Govt. in Steel & Mines Department their notification bearing No. 37/2004 dated 15.01.2004 regarding grant of mining lease in schedule areas.
3. Pending Court Matters, if any.

Authenticated Maps and documents to be furnished

1. SOI Topo Sheet (1:50000) showing forest land required for diversion and boundary of adjoining forest land.
2. Original plan of the mining block.
3. Proposed land use plan in respect of applied forest land of Keonjhar Division (separately).
4. DGPS map showing patch wise DGPS coordinates of the forest land under different category involved in the mining block proposed for diversion and DGPS coordinates of all patches of forest land involved in the mining block (Keonjhar Division)
5. Cost benefit analysis of the project.
6. Details of approvals obtained/ sought for under the Act in respect of the project.
7. Check list in the prescribed format along with specific information.
8. Status of settlement of rights under the Forest Right Act, 2006 of forest land proposed for diversion should be submitted.
9. Equal the extent of non-forest land proposed for diversion should be required for CA.
10. The details land schedule of the proposed area should be appended in the diversion proposal duly authenticated by the concerned Tahasildar & Range Officer & User Agency (separately for Keonjhar Division)
11. Whether the proposed forest land is a part of National Park, Wildlife Sanctuary, Biosphere Reserve, Tiger Reserve, Elephant Corridor etc.
12. Certificate as regards Status of land (Forest and Non-forest) as on 25.10.1980.

13. Whether any protected archeological / heritage site/ defense establishment or any other important monument is located in the area. If so, the details thereof with NOC from competent authority, if required.
14. Please, upload the map & KML file separately in web portal in item No. "C" (Keonjhar Division- 9.175 ha & Bonai Division- 47.803 ha) proposed for diversion.
15. Submission of documents in original or photo copy of the same, incase original documents is lost, duly authenticated from the record by the issuing authority with signature and official seal.
