महोदय,

उपरोक्त विषय पर सन्दर्भित पत्र का आशय ग्रहण करते हुए प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी है। अतः राज्य सरकार निम्न बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें। ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:-

1. On perusal of KML file of the proposed road, it is found that the road ends in the dense forest area where no habitation exists. Thus, KML file seems incorrect. State Govt. may upload the correct KML file of the area proposed for the road at para C (ii) (b), Part I online.
2. Documents uploaded at para D (i), D (ii) a, L (iv) f, L (iv) g and L (iv) h found incorrect. State Govt. may submit/ upload the correct documents against each para.
3. Cost benefit analysis found uploaded/ submitted in the old format. State Govt. may upload/ submit the cost-benefit analysis in the new format.
4. FRA certificate of DM uploaded online found undated. State Government may upload the FRA certificate of DM with date.
5. It is seen that photocopy of all the documents found uploaded in Part I. State Govt. may upload the original documents and the same should be in order.
6. Administrative approval, land schedule and Muck Disposal Plan uploaded online is neither complete nor clear. State Govt. may upload the clear and complete scanned copy of the Administrative approval, land schedule and Muck Disposal Plan online as additional document.
7. It is seen that CA scheme uploaded and submitted are different. Further, name of the area mentioned in CA scheme uploaded online is Gangreti and Juaa in Hard copy and in Part I. State Govt. may clarify and provide correct information in this regard.

8. Name of the area is not mentioned in CA site suitability certificate uploaded/ submitted. State Govt. may submit the CA site suitability certificate mentioning the name of CA area.
9. It is seen that details mentioned in NPV calculation sheet found different from the details uploaded/ submitted. State Govt. may submit clarification in this regard and submit/ upload the NPV calculation sheet providing the correct details.
10. Bar chart and geologist report uploaded online are not clear. State Govt. may upload the clear scanned copy of the bar chart and geologist report online as additional document.
11. Aerial distance certificate not found uploaded/ submitted. State Government may upload/ submit the aerial distance certificate.
12. List of trees falling in 0-20 dia class not uploaded/ submitted. State Govt. may submit list of trees falling in 0-20 dia class and upload the same online at para-4, Part II.
13. SoI toposheet map of the area proposed for road has not been submitted in hard copy. State Govt. may submit the original copy of SoI toposheet map of the area proposed for road duly authenticated by DFO.
14. इसके अतिरिक्त राज्य सरकार लाभान्वित होने वाले ग्रामों की स्थिति KML file पर अंकित कर ऑनलाईन पैरा C(ii) (b) पर अपलोड करना सुनिश्चित करें।

यदि चाही गई सूचना पत्र जारी होने की तिथि के 60 दिनों के भीतर (अधिकतम 90 दिन) इस कार्यालय में प्राप्त नहीं हुयी तो प्रस्ताव को निरस्त किया जा सकता है।
