
Undertakings/ Certificates to be furnished

3. Certificate as regards Status of land (Forest and Non-forest) as on 25.10.1980.
(NB: The status certificate should be correct and complete in respect of all plots involved in the project).
4. Certificate under FRA-2006 in respect for the forest land involved in the project.
5. Pending Court Matters, if any.

Authenticated Maps and documents to be furnished

1. SOI Topo Sheet (1:50000) showing forest land required for diversion and boundary of adjoining forest land.
2. Proposed land use plan in respect of applied forest land.
3. DGPS map showing patch wise DGPS coordinates of the forest land under different category involved in the project.
4. Cost benefit analysis of the project as per new guideline issued by MoEF.
5. Village wise break up of forest land proposed for diversion.
6. Details of approvals obtained/ sought for under relevant Acts in respect of the project.
7. Correct status report as regards area of non-forest land as on 25.10.1980 involved in the instant proposal.
8. Land schedule of forest land applied for diversion in the instant proposal.
9. Details of land identified for CA with GPS coordinates of the identified site.
10. Check list in the prescribed format along with specific information.
