Sub: Diversion of 8.543 ha forest land in favour of Chhattisgarh Road Development Corporation (CRDC) for Upgradation and Widening to 2 - lane of Chhuriya - Kallubanjari Road upto Maharashtra Border in Rajnangaon District in the State of Chhattisgarh. - regarding.

Sir,

I am directed to refer to the State Government of Chhattisgarh's letter no. F-5-20-/2018/10-2 dated 25.07.2018 on the above subject seeking prior approval of the Central Government under the Forest (Conservation) Act, 1980 and this office letter of even number dated 29.08.2018 forwarding shortcomings as found in instant proposal and to say that query letter sent to State Government vide dated 29.08.2018 was inadvertently copied from another file of same project. Accordingly, the shortcomings as found after examination of instant proposal in Regional Office (WCZ), Nagpur revealed following:

- Part-I and II has been submitted without mentioning date of submission, further, Part-II and III does not have name of signing authority.
- Specific recommendation of the DFO with Part-II has not been uploaded in online portal.
- Certificate, from the DCF concerned, regarding location of the project outside the PAs and whether the area is located within a distance of 10 km from the boundary of PAs has not been submitted.
- Certificate regarding barest minimum requirement of the Forest land for the proposal has been submitted by User Agency and same need to be submitted by DCF concerned.
- Examination of proposed alignment in Google satellite imaginary revealed that a considerable forest land might be avoided by shifting present alignment towards western direction in compartment no. P-647 and P-643. Accordingly, State Government may explore the possibility of shifting present alignment towards western side in compartment no. P-647 and P-643 to a void forest land.
- Examination of compliance of Scheduled Tribe and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 revealed resolution/proceedings with respect to Damabanjari Gram Sabha has not been submitted. State Government may ensure the complete compliance of FRA, 2006 in accordance to MoEF&CC advisory issued vide letter dated 5th July, 2013.
- DGPS map of land proposed for diversion is submitted in very small scale and same need to be submitted in larger scale.

- viii. Index Map/Sol Toposheet on 1:50,000 scale dully imposing land proposed for diversion has not been submitted.
- ix. Instant proposal is for widening and upgradation of existing road; accordingly details of any new alignments/bypasses proposed in forest area may be submitted by the State Government.
- x. Area calculation statement, in tabular form, indicating the forest patch wise length and breadth along with the detail of area left on both left and side of the bifurcated forest patch may be submitted by the State Government. Further, details of area of forest patches being bifurcated from the proposed rehabilitation/upgradation work or re-alignment, if any, may also be submitted by the State Government.
- xi. Details of employment potential in terms of man days of skilled, semiskilled and unskilled persons on permanent (direct and indirect) and temporary (direct and indirect) basis have not been provided.
- xii. An undertaking may be obtained from the User Agency, in accordance with the MoEF&CC's Guidelines dated 7.01.2013.

In view of the above, the State Government is requested to submit the complete information as mentioned above, to this Ministry for further necessary action in the matter.

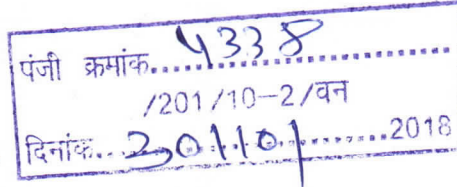
