Sub: Diversion of 22.80 ha Protected Forest land for construction of cement concrete road with other underground amenities like water supply, Drainage, Storm drainage line, Street light etc. and allied works from Pal(RTO) Hajira Road to Palanpore gam Canal culvert and on both side of existing canal from Pal-Palanpore- Bhesan Gauravpath to Vanakala Jakatnaka (up to outer ring road) in favour of Executive Engineer, Road Development Department, Surat Municipal Corporation in Surat District of Gujarat.

With reference to above mentioned subject and letter under reference, I am directed to request you to provide following information/clarification: -

- 1) As per DSS, proposed CA show MDF over 13.00 ha out of 46.00 ha and CA scheme of Model No. 2 with 858 nos. of sapling/ha is submitted. Thus, the CA on open forest shall be submitted along with all required documents as per Para 2.8(iii) of FCA Handbook 2019.
- 2) The revised site specific CA scheme shall be submitted as per the para 2.8(iii) of FCA Handbook 2019 and shall include the following points also :-
 - a) Saplings to be planted (Minimum standard height and collar girth specie wise).
 - b) Soil & moisture conservation works.
 - c) Regeneration cleaning.
 - d) Silvicultural and other activities as prescribed in the working plan.
 - e) Species to be planted (species wise number of plants).
 - f) Details of proposed monitoring mechanism/ outcome parameters.
 - g) Technical and administrative approvals from the competent authority.
 - h) The revised CA scheme shall be uploaded on e. portal.
