Above mentioned online proposal (PART-I, II and III) by this office received on 03-11-2018 through FC web portal and subsequently the hard copy on 17-11-2018 have been examined. It is noticed that the extent of the forest land requirement in PART-I has been revised by the User Agency from 0.1818 hectare earlier (at the time of acceptance by this office) to 0.0909 hectare during processing of the proposal at field level, but necessary corrections have not been incorporated in several Items in PART-I and PART-II. Accordingly, the following Items in PART-I and PART-II need correction.

1	<b>PART-I Item A-1(x):</b> Total period for which the forest land is proposed to be diverted (in years)	Period of required lease is not mentioned resulting in 'NIL' display in this Item. <b>Please mention the period in years for which the lease of forest land is proposed.</b>
2	<b>PART-I Item C (II)(a):</b> Kml File of Patches	Uploaded KML polygon shows an extent of 0.0769 hectare as against 0.0909 hectare mentioned in other relevant Items in PART-I. Further, the four GPS readings mentioned on the Topo Map and Georeferenced Map do not match with KML polygon. <b>Please provide the correct GPS readings which match with the KML polygon correctly.</b>
3	<b>PART-I Item C(iii):</b> Copy of Survey of India Toposheet indicating boundary of forest land proposed to be diverted	Location of the project is not marked on the Map. There is no Map Index and Toposheet No. mentioned. Further, the Map is not signed by the User Agency. <b>Please ensure that the Topo map :</b> 1. has the location of the project distinctly marked on it. 2. has the Map Index and Toposheet number



		<b>3. is ink-signed by the User Agency.</b>
<b>4</b>	<b>PART-I Item C(iv):</b> Scanned copy of the Geo-referenced map of the forest land proposed to be diverted prepared by using GPS or Total Station	The Geo-referenced Map is not signed by User Agency. <b>Please ensure that the uploaded map is ink-signed by the User Agency.</b>
<b>5</b>	<b>PART-I Item D(i)</b> Copy of note containing justification for locating the Project in forest land	<u>Uploaded document is not in English.</u> As the FC proposals involve processing/ scrutiny by Government of India, <b>all uploaded documents need to be in English.</b> In case of non-English documents, <b>please upload an English translation duly authenticated/attested by the Competent Authority/User Agency.</b>
<b>6</b>	<b>PART-I Additional Information Details</b>	<u>Undertaking to pay NPV and other statutory charges has not been uploaded.</u> <b>Please upload an Undertaking to pay the Net Present Value (NPV) and other statutory charges as per applicability and norms.</b>
<b>7</b>	<b>PART-III Item 15</b> (Site Inspection report of CCF)	An irrelevant document (not connected with present proposal) has been uploaded in Item 15(ii). Further, the Date of Inspection by CCF is wrongly shown as 30-11-2018. The hard copy of the Site Inspection Report mentions the date of inspection by CCF as 30-10-2018. <b>Please remove all such anomalies and upload the correct document.</b>

In view of the above, the above deficiencies need to be rectified by the User Agency in PART-I and by DCF/ CCF in PART-II/III by transferring the link through EDS Query option on the web portal and then resubmission online to this office on priority.

The online proposal is therefore returned for necessary action.
