ं उपरोक्त संदर्भित पत्र द्वारा प्रस्तुत प्रतिउतर का ध्यानपूवक अवलोकन करने के पश्चात प्रस्ताव में अभी भी निम्नलिखित कमियां पाई गई है:—

- 1. In reference to EDS observation no-1, State Govt has not submitted any comments regarding the impacts of all the HEPs Commissioned/under Construction/Proposed on nearby Landscape. Therefore same may be provided/uploaded on the PARIVESH portal. Additionally, approved capacity in terms of hydro-electricity generation potential of the river/rivulet may be provided.
- 2. In reference to EDS observation no-1, the revised KML file has not marked with all the components. Therefore, UA may upload the revised KML file properly showing all the components along with legends in distinct colors on the PARIVESH portal.
- 3. FRA certificate has been submitted, however a copy of records of all consultation and meeting of the Gram Sabha and FRC of the concerned Village (Paradi) as desired may be submitted.
- 4. As per DSS analysis, proposed diversion area is having Very Dense Forest category (>.4) in more than 01 sq. km area. Therefore, the State Govt. may review and provide comments in this regard. Also, density class and NPV calculation sheet/Bill may be revised accordingly.

You are, therefore again requested to kindly ensure to submit the reply to IRO, Shimla only after satisfactory compliance of all the observations/shortcomings as mentioned above.
