With reference to above subject, the online proposal (PART-I, II & III) received by this office vide Ref (1) to (3) have been examined. It is noticed that the DCF, Karwar reported in his site inspection report that only 1.13136 Ha out of 1.53939 Ha falls in forest area and remaining area is non-forest land. But you have recommended for the entire extent of 1.53939 Ha as forest area. The proposal cannot be sent to GoK because of this discrepancy.

Therefore, you are directed to clarify the above issue and then submit the reply through FC web portal to this office for further action.
