विषय: Diversion of 1.8686 ha of forest land in favour of Technical Education, Vocational & Industrial Training H.P. Sundernagar, Distt. Mandi, H.P. for the construction of Govt. Polytechnical College Dalash, within the jurisdiction of Ani at Luhari Forest Division, Distt. Kullu, H.P. (Online Proposal No. FP/HP/Others/147489/2021).

महोदय,

उपरोक्त विषय पर संदर्भित पत्र का आशय ग्रहण करते हुए सूचित करना है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी है। अतः राज्य सरकार निम्न बिन्दुओं पर आवश्यक सूचनाएं प्रेषित करने का कष्ट करें, ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:-

1. The extant proposal is a non-site specific project. As per Para 1.15 of FCA guidelines and as well as recent directions from MoEF & CC letter dated 24.01.2022 has categorically instructed that non site specific activities cannot be considered on forest land as a rule. For that matter, no non-site specific proposal can be entertained for considered approval under FCA, 1980. Therefore, State Govt. may explore non-forest land (private land) for the project.
2. Since this is a non-site specific project, the State Government may explore the alternatives in non-forest land in more details.
3. Additionally, as per the Online Application Form-A, Part-II, Para-5, Working Plan prescription for the part of forest land proposed for diversion is mentioned as '**Since the Working Plan of Ani Forest Division has been expired on dated 31.03.2015 and as per new draft Working Plan, the area falls under Protection Working Circle.**'. Hon'ble Supreme Court in Writ Petition (Civil) No. 202 of 1995 T.N. Godavarman Thirumulpad Vs. Union of India and Others in its order in its Order in Interlocutory Application No. 3840 of 2014 dated 11 March 2019 has directed that '*... There shall be **no diversion** of the forest lands allotted to a Protection Working Circle in any Working Plan under FRA and FCA..*'.

Therefore, the State Government must explore alternative sites for the extant proposal outside Protection Working Circle.

In view of the above, the instant proposal is not plausible to process at the IRO level in the absence of essential documents and necessary comments from the State Govt.
