Madam,

With reference to the subject and reference cited above, it is to state that the subject proposal was examined by this office and noticed that DFO reported that UA carried out work in violation of FCA, 1980 over an extent of 0.25 ha. All the proposals involving violation of the provisions of FCA, 1980 shall be processed as per the guidelines issued by the Ministry from time to time.

Further, the instant proposal is required to be processed as per the Forest (Conservation) Rule 2022. The Regional Offices can not consider the proposals involving violation of FCA, 1980 as per the Rule 9 (5) (a). Such proposals are to be submitted by the State Government to the Ministry for consideration.

Keeping in view of the above rule position and the guidelines from the Ministry, the proposal is **returned** herewith with a request to to process it as per FCR 2022 and the guidelines issued by the Ministry regarding processing of proposals involving violation of FCA, 1980..
