With reference to the above subject, this office vide Ref (1) has submitted the proposal to Government of Karnataka for seeking 'in-principle'(Stage-I) approval under Section 2 of Forest (Conservation) Act, 1980. The Government of Karnataka vide Ref (2) letter dated 09-12-2022 has forwarded the proposal to Government of India.

In response, Government of India vide Ref (3) has informed that DCF in his site inspection report has stated that the Forest (Conservation) Act, 1980 has not been violated in the instant case. However, as per the satellite imagery, the proposed forest land has already been utilized for non-forestry activities without prior approval under Forest (Conservation) Act, 1980 and therefore, the proposal is required to be processed as per the guidelines vide letter No. FC-11/113/2022-FC dated 08-09-2022.

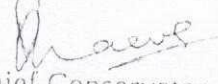
It is therefore, requested that a detailed report on violation including the names of the erring officials and their present place of posting may kindly be furnished to this office for taking further action on violation of Forest (Conservation) Act, 1980 (Copy enclosed).

Accordingly, Government of Karnataka vide ref (3) letter dated 31-01-2023 had communicated the same to this office. Therefore, you are directed to submit clarification/information sought by Government of Karnataka after obtaining the same from the Deputy Conservator of Forests, Bagalkot and User Agency. The
