With reference to the above cited Memo Nos. on the captioned subject, it is to inform that the Proposal for diversion of 87.520 ha of forest land including alternate road for construction of Hidsingh irrigation Project under FC Act, 1980 by Executive Engineer, Cuttack investigation Division, Jobra, Cuttack.

In view of the above, the Principal Chief Conservator of Forests, Nodal, FC Act. O/o the PCCF, Odisha, Bhubaneswar has made observations vide his memo No. under reference (5) copy enclosed for your reference.

Further, you have wrongly applied the Wildlife Clearance for Hidsing Medium Irrigation Project. On scrutiny of the Wildlife Clearance form and the following deficiencies are noticed.

Sl. No. 4. Location of the Project or Activity.

Sl. No. 4.1 Upload KML.

Sl. No. 5 KML file uploaded of the project is 2305779_WL_KML_1686297541689_Project location new.kml with an area of 3825.09 Ha. However, total Land Requirement (in Ha) of the project or activity is mentioned as 437.33 Ha.

Sl. No. 7. Employment likely to be generated.

Sl. No. 7.1.3. No. of man-days for Permanent Employment is mentioned as 735000 and temporary employment as 7000 man days during construction phase which may be recertified.

Sl. No. 7.2. During Operational Phase, Permanent and Temporary Employment details are to be provided.

Sl. No. (10) - Whether any alternative site(s) examined or part thereof for the non-site-specific component?

It is required to explore atleast three numbers of alternative routes for the construction of roads. Details thereof should be uploaded in the Parivesh Portal. Total area of the locations uploaded in Sl. No. 33(0) is 398.711 Ha while as per Sl. No. 21.4.1 Division-wise breakup of land required is 437.33 Ha. The following details of proposed lands does not match with the tabular data.

Sl. No. 21.4.2 Component-wise breakup of land required - Linear Nil information has been provided and Right Main Canal, Left Main Canal and Alternative Road are included in the Non-linear category.

Sl. No. 21.4.2.1.1 Upload animal passage plan: - No measures have been suggested for wildlife crossing over the linear components of the project i.e., over canals and roads. Animal Passage plan approved by the competent authority should be uploaded accordingly.

Sl. No. 21.5 Total period for which land is required (years) is mentioned as 30 which should be revised.

Sl. No. 21.10 Scanned copy of the Geo-referenced map of the project area with respect to the protected area prepared by using DGPS or Total Station (pdf only) - Uploaded copy is not legible.

Sl. No. 27.12 Type of Irrigation is mentioned as Drip.

Sl. No. 39 Copy of the approval of competent authority to the Catchment Area Treatment Plan (CAT Plan) (in case of proposals > 10 MW) - Uploaded documents are not required.

Hence, you are requested to comply the above observations and submit the compliance report to the above wildlife clearance proposal to the undersigned immediately for submit the same to higher quarters in due time for taking further action in the matter.

- 1. The CAT Plan does not includes any plantation or a component of fodder development in order to meet the requirement of fodder/ smaller timber/ fire wood for the local population with a view to reduce pressure on the forests.
- 2. The measures proposed in the CAT Plan have no details. The dimensions of the structures are not furnished. Moreover the rate furnished is very arbitrary and not in consonance with any of the approved cost norm.

In view of the above, the CAT Plan in triplicate are returned here with to comply the deficiencies as pointed out above and resubmit the same to this office by 10^{th} of this month by adhering to the stipulations as per Chapter- 9 of Hand Book of Forest (Conservation) Act, 1980.
