

With respect to the above-mentioned subject, hard copy of the proposal has been submitted by your office letter vide Ref (1). The same has been verified in this office and it is found incomplete in the following aspects:

1. The non-forest land identified in Sy.no. 65 of Sasalu Village, Doddaballapura for raising Compensatory Afforestation is not suitable as per DCF, Bengaluru Rural Division letter vide Ref (2) as it is already planted by the department. Hence, alternate non-forest land should be identified by the User Agency.
2. CA suitability Certificate, CA scheme, RTC is not provided.
3. Instead of 18.60 ha, 16.36 ha has been mentioned in FRA certificate. Hence the revised FRA certificate needs to be submitted.


4. Part-II and jurisdictional DCF letter is not submitted.
5. There is no signature of the field officers in the topo-sheet, village maps, Cadastral maps and in other documents.

While enclosing herewith the proposal, you are directed to obtain the required information from the User Agency through jurisdictional Deputy Conservator of Forests, verify and then submit through FC web portal along with minimum 3 ink-signed sets to this office for further action.
