महोदय,

उपरोक्त संदर्भित पत्र द्वारा प्रस्तुत प्रतिउत्तर का ध्यानपूर्वक अवलोकन करने के पश्चात प्रस्ताव में अभी भी निम्नलिखित कमियां पाई गयी हैं:-

1. In response to observation 1, State Govt. has uploaded a fresh KML. However, as per the DSS the calculated area of the proposed DA is 0.11 ha instead 0.28 ha, therefore necessary correction may be done.
2. In response to observation 3, State Govt. has submitted the Bill of CA instead of 10 years planation scheme as per para 2.8 (iii) of FCA guidelines, 2019. Therefore, plantation scheme may be uploaded
3. The clarification/documents regarding the following may also be provided: -
 - i. Complete legible list of 2183 roads provided by HPPWD to Hon'ble High Court of Himachal Pradesh constructed in violation of FCA, 1980 highlighting the Sl. No. and name of the road of the extant proposal.
 - ii. Copies of the Orders of the Hon'ble High Court of H.P. which clearly finds mention of regularization of 2183 roads which have already been constructed in violation of the provisions of FCA, 1980.

As per the latest direction of the Ministry of Environment, Forest and Climate Change, Government of India vide File No. FC-7/43/2020-FC dated 22.03.2022, the proposals for use of forest land for non-forest purposes which includes violation of Forest (Conservation) Act, 1980 as specified in Para-1.21 (i) and (ii) will be examined at the level of Ministry after discussion in REC. Therefore, the State Government is requested to submit the reply to this office at the earliest
