Inviting reference to the correspondence on the captioned subject, I would like to inform you that the Site Inspection of the proposed site could not be carried out by the undersigned on 29.11.2015 due to non identification of Forest land under the proposed project area. The following action need to be taken up at your end to facilitate Site Inspection as well as transmission of the diversion proposal to the competent authority for obtaining approval as per provision of Forest (Conservation) Act, 1980.

1. The proposed Forest area for diversion has not been demarcated in the field. Temporary demarcation by Stone / C.C. Pillar / Bamboo with flags need to be done to take up joint verification & enumeration of tree growth as well as Site Inspection.
2. The Revenue official not below the rank of Revenue Inspector, deputed by the Tahasildar, Remuna & Nilgiri should remain present in the proposed project area to indentify the Forest land to be diverted, during Site Inspection.

The above aspects has been discussed with you vividly in presence of concerned official on 29.11.2015. You are requested to take steps to facilitate demarcation & identification Forest land under of proposed project site within seven days unfliningly.
