Please refer to your office letter cited above wherein, the undersigned was advised to submit the proposal for diversion of forest land under Forest (Conservation) Act, 1980 along with all the necessary documents, besides uploading the application online.

Accordingly, we hereby submit the proposal as mentioned in the rules governing FC Act-1980 for kind perusal in (6) Sets. We submit the full justification in the relevant coloum for seeking diversion of Forest land of **1.3217 Ha** in part-I of Form-A.

It is also to submit that we have explored the entire alternatives for formation of road through non-forest land and only after exhausting all the options, we have proposed this formation of road through Forest area. The proposed road was in use by the villagers to reach the agriculture lands for the last so many years and only recently the Forest Department officials have dug trench along the boundary stating that the area in question is forest land.

In-order to avoid any further legal complications and to have a legal road we are submitting the proposal as our case is genuine and kindly be considered by taking the following facts in to consideration:-

1. We are not causing any loss or harm to the habitation of forest including wild life as the forest land proposed under Diversion is completely on the Edge/boarder line boundary of Reserve Forest and it is devoid of any flora and fauna.
2. The proposal has also been uploaded on the Ministrys website, acknowledgment copy is enclosed for ready reference.
3. We have identified non-forest land for Compensatory Afforestation and ready to hand over the same to forest department.
