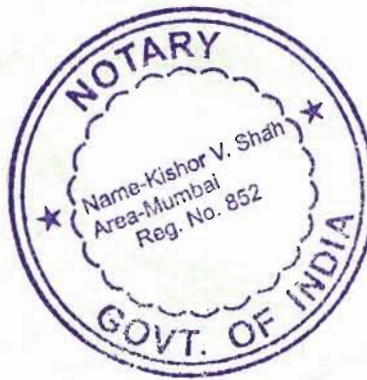

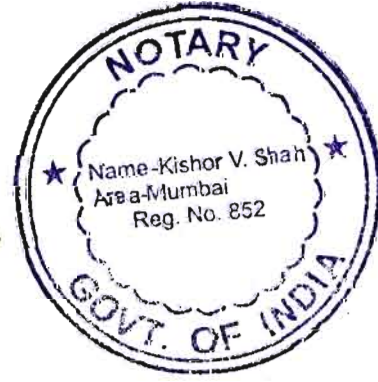


POWER OF ATTORNEY

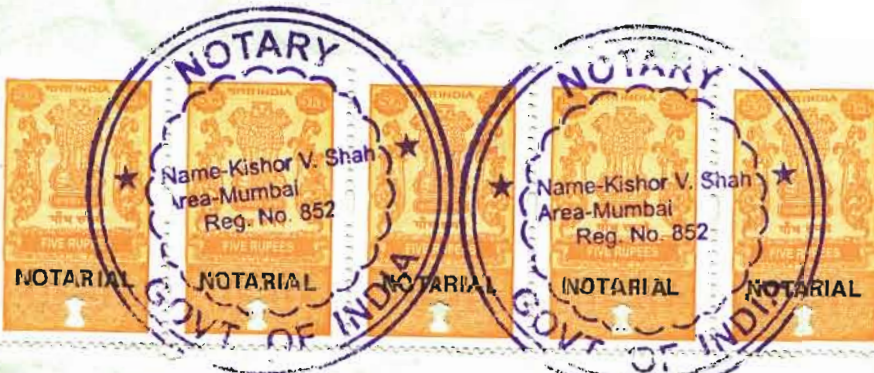
