It is informed that vide ref. 1<sup>st</sup> cited Minutes of the Meeting held by the Committee constituted for recommending the modalities with regard to establishment of Andhra Pradesh Forest Academy at Diwancheruvu, Rajamahendravaram held on 27-06-2014 was communicated to the Conservator of Forests , Rajahmundry and Divisional Forest Officer , Kakinada. Accordingly, the Divisional Forest Officer , Kakinada vide ref. 2<sup>nd</sup> cited has submitted the DGPS surveyed map of the proposed location for establishment of A.P. Forest Academy located in Diwancheruvu (East) RF, falling in Kakinada (Territorial) Division. The same was verified by the "IT" Wing of this office and authenticated confirming an extent of 39.13 Ha for establishment of A.P. Forest Academy for imparting statutory trainings on Forest Protection, Management and Conservation to different levels of field officers, awareness building of the various stakeholders included in forest management and their capacity building.

Since the intended of area is located in notified Forest, formal proposal for diverting the land for the above purpose has to be submitted in appropriate format as per F(C) Act, 1980 to the Government of India.

The Divisional Forest Officer , (Territorial) , Kakinada is therefore authorized to upload the proposal in all respects and act as User Agency on behalf of Prl. Chief Conservator of Forests (Head of Forest Force) .

After uploading the proposal, the formal scrutiny shall be done by the Divisional Forest Officer , Kakinada in Part – II of format –A and submit his remarks further to the Conservator of Forests , Rajamahendravaram for recording his remarks in the Part –III and submit the same to the Prl. Chief Conservator of Forests (Head of Forest Force) , A.P. Guntur at the earliest.


