This is in reference to above subject we would like to inform you that Jio Digital Fibre Pvt. Ltd. having its registered office 101, Saffron, Nr. Center Point, Panchwati 5 Rasta, Ambawadi, Ahmedabad-380006, Gujrat, India and registered with Department of Telecommunications (DoT) Govt, New Delhi as Infra Structure Provider Category I (IP-I) vide registration certificate No. 370/2011 dated, 23rd June 2011.

We are planning to lay Optical Fiber Cable (OFC) through duct, adopting various methodologies like HDD, Open Trench, Clamping and other suitable method as required on the ground in the subject Forest Area to construct a fibre optic backbone link.

The OFC will be laid Under Ground along roads in ROW only

It is worthwhile to state here that Govt and Government of Rajasthan attach lot of importance to provide quality Internet/Mobile Service. Hence the Govt has constituted a committee vide order No. F 6 (9/AR/Gr 3/2014 dated 21/1/2015 to accelerate roll out of 4G Network in the state. ACS (Forest) is one of the members of this committee. One of the Terms of References (TORs) of the aforementioned committee is related to grant of requisite permissions/approvals for laying of OFC.

Considering requirement of infrastructure development & its expeditious use, the MoEF, Govt has also conveyed general approval u/s 2 of Forest (C) Act, 1980 for underground laying of OFC by letter No.F.11-9/98-FC dated 16/10/2000 & letter of even number dated 08/04/2009 till further orders.

The Govt has constituted a committee under the Chairmanship of CE & Addl. Secretary PWD to accord approval to the proposals of laying of OFC in RoW along roads through Single Window Clearance System (SWCS).

For according approval to the proposals of laying of OFC along roads in ROW, NOCs/ Permissions of Forest Department from appropriate levels are required by the committee mentioned above.

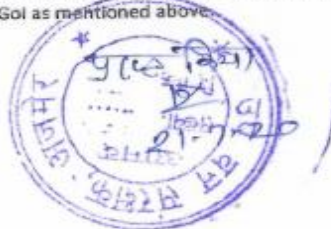
We are enclosing herewith the requisite documents for the NOC/ permission to lay the underground OFC as per check list along with route diagram and copy of IP-1 License.


