Dear Sir,

Power Grid Corporation of India Limited (A Government of India Enterprise), a Central Transmission Utility of India, under Ministry of Power is entrusted to construct and maintain EHV transmission lines within and across the region in order to transmit bulk power with security and reliability.

As a part of that, Power Grid Corporation of India Limited is constructing 400 kV D/C Mouda-Betul Transmission Line to provide power to major load centre and agricultural industry and to improve power scenario in general in western part of India. The above project shall have to be completed within stipulated period of time.

The said line is passing through the Forest area of Vill. Mehandi and Vill. Pipla Ta: Parseoni, Dist:Nagpur under Nagpur Forest Division. Though utmost care has been taken to avoid Forest area, forest patch in above villages is unavoidable and the involved Forest area is barest minimum.

In this regard, Forest proposal for diversion of 1.705 Ha. Forest Land has been submitted and accepted by Nodal officer, Nagpur. Copy of acknowledgement is attached herewith. Hard copy of Forest proposal alongwith necessary enclosures is being submitted.

You are kindly requested to process the case keeping in view the urgency and the importance of the project.
