Subject: Augmentation and Strengthening of Drinking Water Supply , 30MLD WTP, MBR & ESR/OHT1 in Adityapur Municipal Corporation in the State of Jharkhand –Submission of Hard Copies of Forest Clearance Application (FC Proposal No. FP/JH/Water/47700/2020).

Urban Development and Housing Department provides civic amenities in urban areas and extends support through Urban Local Bodies to the entire citizen as well as shares the responsibility of ensuring planned development of the city and its outskirts. As part of it, UDHD has taken up the augmentation and strengthening of existing water supply in Adityapur town through Adityapur Nagar Nigam. UDHD has authorised JUIDCO to implementing the aforementioned project.

The proposal includes upgradation of existing water supply lines, construction of OHT & MBR and establishing new Water Treatment Plant to meet the future water demand of Adityapur Municipal Corporation.

The proposed project requires diversion of 3.8055 Ha forest land for construction of water Supply line, 30MLD WTP at Sitarampur Village, Master Balance Reservoir (MBR) at Krishnapur and Elevated Service Reservoir (ESR) /Over Head Tank (OHT) -1 at Asangi. Accordingly, Forest Clearance application was prepared and uploaded in FC web portal on 24.03.2022. Nodal officer, Jharkhand State Forest Dept. has accepted the proposal for its completeness on 30.03.2022 and informed to submit the hardcopy of the FC proposal to concerned officials. Please refer the attached timeline for the same.

In this regard, we are submitting the hard copy of the Forest Clearance application in one set for the initiation of settlement of rights under FRA 2006 and issuing certificate for recognition of forest rights for project affected villages/wards and also Issuance of certificate on non-availability of alternative suitable non- forest land for the project.

As the proposed project is intended to provide portable drinking water to Adityapur citizens, we request you to kindly expedite the forest clearance process.
