Sir,

The work of Construction of 4-lane Bypass on WESTERN Side of Gwalior City (design length 27.800 km) in the State of Madhya Pradesh is proposed for development by the National Highways Authority of India. This stretch of the road primarily runs in N-S direction and connects Morena, Gwalior, Shivpuri & other important Blocks and Tehsil Headquarters located at route. The project road passes through Kuleth R.F., MGV R.F. Raipura, Sujwaya Beat & Devkho Beat at Gwalior division in Madhya Pradesh state.

Hon'ble Aviation Minister, Shri Jyotiraditya Scindia held meeting on 23.09.2021 to discuss various development works of Gwalior district. In the meeting NHAI officials were directed to pursue an alternate alignment of length of 27.800 Km instead of the alignment of the length 29.806 Km. as suggested by PCCF(Wildlife) in the meeting dated 15.02.2021. Also, during the REC meeting of MoEF held on 02.11.2021 it was directed to this office to pursue forest clearances on the alignment preferred by Hon'ble Minister and the district administration.

In compliance of aforesaid directions, the forest proposed (Proposal No. FP/MP/ROAD/141174/2021) submitted earlier for diversion of 19.695 Ha. land was withdrawn by this office vide letter dated 03.11.2021 and afterward requested for re-conducting joint inspection, same has been conducted alongwith SDO, forest. Accordingly, Forest Clearance proposal has been uploaded by NHAI in PARIVESH portal on 23.11.2021 for seeking forest clearance in an area of 39.41 Ha.

As against the 27.800 km, existing 15.600 km two lane road is to be upgraded to the four lane carriageway. Therefore, the name of the project is rehabilitation & up-gradation of the newly declared of Bypass on western side of Gwalior to Four lane road with paved shoulder in the state of Madhya Pradesh.
