Government of India accorded approval of 221.8 hectare of forest land in Jogimatti and Marikannive Reserve forest vide F No. 8-84/2002-FC dated 02-04-2003 (Stage-1) & dated 27-5-2003 (Stage-2) respectively and GOK order No. FEE-99-FGL-2001 dated 20-06-2003. Subsequently, lease deed has been executed between Forest department and KREDL (Applied proposal on behalf of Enercon (India) Limited presently Wind World India Ltd) for 15 years as per lease deed agreement no.2/2003-2004 dated 03-09-2003.

The said lease period had expired on 02/09/2018 and Wind World India Ltd has already applied proposal for Renewal of Forest land Lease on 06/07/2018 through online process as proposal no. FP/KA/WIND/34510/2018 which has been withdrawn due to technical error in address updation of user agency.

After that proposal no FP/KP/WIND/42832/2019 submitted on 15/11/2019 which has been withdrawn due to technical error in area updation of the proposal on online Parivesh portal of forest clearance.

According to latest survey using DGPS, we have used 106.769 hectares of the land in the total approved forest land of 221.80 hectares for the development of the project resulting in saving of 115.031 hectares area of forest land and we are also ready to surrender the unutilized land of 115.031 hectares.


