I am here with submitting an online application in the form A part-I along with related documents, for the diversion of forest land for, conversion of existing 110KV Single Circuit line to Double Circuit line from 220/110/33/11KV Sub-Station Mahalingpur to 110/33/11KV Sub-Station Jamkhandi in Bagalkot District for a distance of 23.897 Kms in which the 6.895 Kms line passes through forest land.

The existing 110KV Single Circuit line constructed long back and now due to the aging of the towers, abnormal sags of the line conductor, it is necessary to strengthen the line immediately, to avoid any hazardous possibilities, which may occur in near future.

Hence, it is proposed to construct a new Double Circuit line in the existing corridor from 220KV Mahalingpur Sub-Station to 110KV Jamkhandi Sub-Station.
