Navi Mumbai Municipal Corporation (NMMC) has proposed the work of "Providing and laying of main sewer line 1400 mm dia. From Juinagar sector 22 to STP at sector 20 sanpada in Navi Mumbai".

The alignment of this project is passes through small patches of mangrove near Sanpada creek in Sanpada node.

Proposed Site location is not notified as forest/mangrove land. The land related details are given in area statement. The mangrove affected land is considered as forest land as per Hon'ble High Court of Bombay's order for protection of mangroves The area under mangroves land has to be considered as forest hence needs clearance under section 2 of forest (Conservation), Act 1980.
