	2	As per the land particulars submitted with the diversion proposal some plots of Mangalpur (plot 281, 282) and Madhapur (plot 2553) have not been included in the D.L.C forest land proposed for diversion.	Mentioned plot of Mangalpur and Madhapur village have been included in revised diversion proposal and land schedule is enclosed herewith.
	3	As per the DGPS maps submitted with the proposal, it is observed that the stretch of the road covers the plot no 1330,1331,1327 and 1402 in village – Mangalpur, sheet no 3, but the same have not been included in the proposal. Similarly, the plot no 1831 in village – Botalanda sheet no-1 has not been included in the proposal thought the same has been depicted in the map.	Left out plots of Mangalpur and Botalanda has been included in the revised diversion proposal
	4	The status of land as on 25.10.1980 from Duburi to Chandikhol involved in the project has not been provided for which the process of diversion proposal being delayed.	This office has already cleared in the letter no 381 dated 18.02.2015 that the stretch Duburi to Chandikhol with RoW of 100 m handed over to NHAI by Govt. of Odisha (Executive Engineer Expressway division Kendrapada) for development. There is no acquisition of land in the stretch and no forest land under this stretch is involved in the project.
