We, M/s Jio Digital Fibre Private Limited (formerly Reliance Jio Infocomm Limited) carrying out laying of underground Optical Fibre Cable to improve communication networking 4G facility at National Level.

As per the advice of Forest Department, we have furnished forest clearance proposal through online in the web portal of www.forestclearance.nic.in and proposal is assigned as FP/TN/Others/38123/2019. Initially we submitted forest clearance proposal for laying the underground Optical Fiber Cable along Royandapuram to Melsiruvallur road via Perungolathur in Thandrapattu – Sankarapuram ODR road across Pavunjipattu R.F. vide reference 1st cited above.

Laying of OFC through this forest area is an important step for the better connectivity of 4G network in this region. There is no possibility of laying OFC except the forest areas proposed, because the forest areas are continuous stretch and this road section passes through the forest areas as admitted right of way leading to Royandapuram to Melsiruvallur road via Perungolathur.

the District Collector, Villupuram for uploading the same in the web portal for taking further action.


Hence, we are furnishing herewith the revised proposal with all enclosures furnished through online for kind perusal.
