Virtuaal Pareng Hydro Private Limited is developing 14.5 mw Pareng SHP in Pareng Village/Circle of Papum Pape District. For evacuation of power from the SHP to the nearest sub-station at Sagalee the company is proposing to build a 132KV S/C transmission line from Pareng to Sagalee for this we had submitted online forest proposal (Copy Enclosed).

This is to request you to initiate FRA in FORM-1 (for linear projects) as required for forest approval (detailed under) -

In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11□ 9/98□FC (pt.) dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non□forest purposes read with MoEF's letter dated 5th February 2013 wherein MoEF issued certain relaxation in respect of linear projects.
