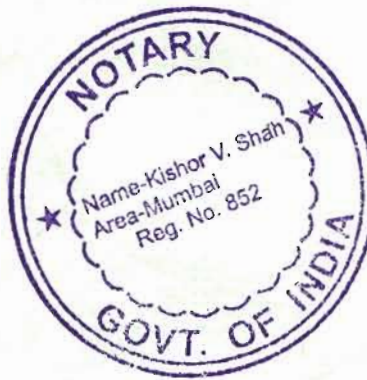

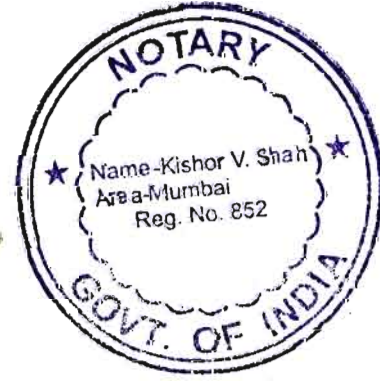


### POWER OF ATTORNEY

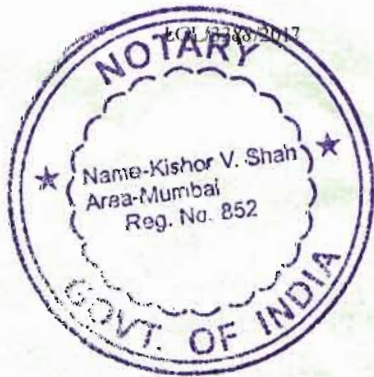

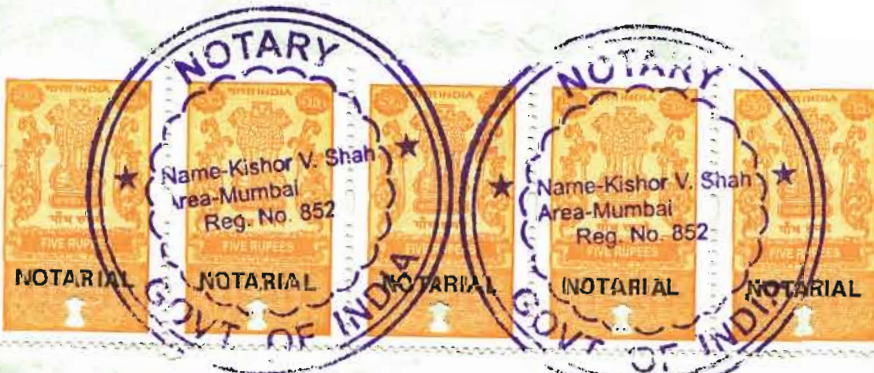
