Sub: Submission of the Hard Copies (6 Set) for the Approval of the 3.3 Ha Forest Diversion proposal for the Construction of Car Maintenances Yard at Malvani for the Mumbai Metro Line 2 A.

Respected Sir

In order to reduce traffic congestion in Mumbai, the Government of Maharashtra through MMRDA decided to expeditiously implement 118 km of elevated Metro corridors of master plan within next 3 to 4 years.

- 2. The Metro Line 2A i.e. Dahisar (E)–DN Nagar (18.60 km) is sanctioned by Govt. Resolution dated 17/10/2015 and the construction work of the project is already commissioned. Vide GR dated 25/10/2016, GoM approved to implement the Metro Line 2B i.e. DN Nagar–Mandale (23.64 km) and Metro Line 4 i.e. Wadala Ghatkopar Mulund– Thane–Kasarvadavali (32.32 km). Govt. has declared all above projects as "Public Project of Urgency" and "Important Urban Transportation Project".
- 3. Further, the approved alignment of the Metro line 2A, 2B and 4 is affected by Mangroves at certain locations which are deemed as 'Reserved Forest' by judgment of High Court in the PIL no 87 of 2006 dated 6th October, 2005. In this regard to avoid obstructions in the construction of Metro projects due to Mangroves affected along the Metro alignment at certain locations, it is necessary to obtain the Forest Clearances.
- 4. In view of above, MMRDA have initiated the proposal seeking prior approval of Central Government under the Forest (Conservation) Act 1980 for the 3.3 Ha Forest Diversion affected by 2.9 Hectare (29534 Sq¹M) land of the total 16.4 Ha of the plot
