In order to provide enough water for drinking, Govt. of Gujarat launched this package Machchhu-1 Based Bamanbor Gr. W.S.S (WSS-6 General) is being under construction which passes Crossing(1)S.No-38 & S.No-16 vil:Vasundra Ta:Wankaner Di:Morbi. Which is declared Forest Land. 0.945 Ha. Protected forest Land is involved in this route. We have considered other alternative to change the alignment but length of the pipeline will increase considerably putting additional burden on the government exchequer. Hence it is necessary to lay the pipeline in the forest area. This land will be utilized only under Right of User (ROU) and there is no any permanent acquisition by government. We are submitting the proposal as per the forest department norms and request you to assign early approval as work is held up for a long time causing a lot of loss in terms of time and money.
