In compliance, this office has submitting 2 (sets in Original) in Form-A Part-I of Signed hard copies of the proposal along with copies of the Certificates / documents & maps, etc. together with a C.D. containing the soft copy of the shape_file/kml_file of the forest land measuring **6.131 ha** proposed for diversion for the location **GOAN** (i) Mouja-Dakshin Sonaichari, sheet No.3, & (ii) Mouja-Tekka Reserve Forest, sheet No.1 & 2, under DFO-South Tripura District. It is worthwhile to mention here that we have not received Non-Encumbrance Certificate in perspective of STOTFD (RFR) Act, 2006 in Form-II (for projects other than linear projects) from your good office.

In view of the circumstances explained above, it is requested your good office to kindly arrange to issue the Non-encumbrance Certificate in respect of STOTFD (RFR) Act, 2006 in Form-II (for projects other than linear projects) for the proposed land measuring 6.131 ha instead of 6.162 ha as indicated in our letter dated 10/06/2019 to enable ONGC to undertake exploration activities uninterrupted in the particular interest of State and larger interest of the Nation.
