
The proposed site was inspected by me on 09-02-2021. The proposal was submitted by the User Agency for requesting prior permission under Forest (Conservation) Act 1980, for diversion of 0.792 ha forest land in Dharmapuri and Hosur Forest Divisions for laying underground Optical Fiber Cable (OFC) to improve mobile network connectivity.

The proposal is for linear project, and it is proposed along the stretches of Pennagaram - Anchetti Road, which is passing through the Pennagaram RF and Woddapatty RF of Hogenakkal Range. During the field inspection of proposed linear path, it is observed that,

1. The proposed length and area mentioned in the proposal of User Agency is slightly higher than actual field condition. The details are,
