## Brief Note on C/O of Prem Nagar Chandog road via Bara Chakli from RD/ 7/00 to 10/200.

The proposal for the construction of Prem Nagar Chandog road Via. Bara Chakli in Km. 7/00 to 10/200 has been taken by the PWD with the help of State Government. The A/A & E/S for construction of the said road was accorded by the Principal Secretary (Social Justice) under head Schedule Cast Sub Plan (SCSP) vide letter No. SJE-C(10)28/2006 dt. 31-01-2007. The road from Prem Nagar to Chandog Km. 0/0 to 7/00 has already been constructed under NABARD. The approval of competent authority for diversion of 2.53 hectare of forest land has been conveyed vide letter No. 9-1394/2002 ROC 11844 dated 30-12-2002. This road falls under the jurisdiction of B&R Division Rajgarh and in forest division Rajgarh. But during the year 2007 the PWD authorities has constructed the road in between Kms 7/027 to 8/662 in Private land under possession of various land owners with land status as "jungle jhari" in some portion of forest land due to none awareness/identification of status of land, which were under the possession of various land owner and attracts the provision of FCA 1980. The RD wise detail in which the FCA violated by the User agency is as under:

The road in between Km. 7/00 to 8/562 at different RDs stand constructed, which are in the possession of various land owners, with land status obad khadi, Banjar Kadeem, Nakabil Jungle Jhari, Gair Mumkin Khala and some portion of forest land. Hence already constructed portion including forest land and land with states as jungle-jhari having total length in different RDs i.e. 700 mts covering 4200 Sqm. Area attracts the provision of FCA, 1980 which is included in proposal folder as violation of FCA, 1980.

Thus from the above mentioned facts, it is clear that 1818sqm forest land & 2382 sqm in private land areas violated by the user agencies due to non awareness/ identification of the status of the land in which the road was constructed. Also this violation has not been conveyed in the violation list of road inadvertently. Work of this portion of road was awarded to Sh. Ashwani Gupta Contractor vide letter No. PW/RGH/Estt/Tender /2005-06-16244-51 dated 24-1-2007 amounting to Rs.5,21,304/- and work executed by the contractor in this portion entered in MB No. 1714,1746,2083,page 90, page 92 for which Rs.3,47,625/- has been paid to the contractor up to 7/2007. Now the construction of balance work of the said road is to be taken under PMGSY.
