


Sir,




With the context of above noted subject and proposal IRO Jammu has raised EDs that the entire stretch of 6.00 km road of proposed road is not plausible in absence of written Administrative Approval for 6.00 km. of road.

Now as per EDs and DPR we have reduced the length of the proposal from 6.00 km to 5.00 km (in the KML file) as a result of which the Forest area has been reduced from 2.43 hac to 1.71 hac and the area of private land (Non Forest Area) reduced from 2.97 hac to 2.79 hac. As necessary correction in the Forest area has already been made by your goodself. Now we are trying to make an amendment/recast in Form-A Part-I in the Parivesh Portal with report of the non forest area but not able to modify the non forest area (area of Private land) as the edit option is not working.

It is as such requested to your goodself kindly allow to make necessary amendment for the same in Form-A Part-I of Parivesh Portal.

Early and favourable action is solicited please.
