Sir,

In reference to the GoI letter cited above on the captioned subject, the DFO, Mangrove (WL) division, Rajnagar and RCCF, Bhubaneswar Circle have reported the following compliance to the observation raised by the MoEF&CC, GoI.

Observation (i):-The reply letter of the state dated 04.11.2022 has been uploaded on the portal on 23.05.2023. The reason for uploading this letter in extraordinary delay may be submitted and the Annexure-I series has also not been found /uploaded with the forwarding letter on the portal.

Compliance :-The user agency i.e. Paradip Port Trust has submitted the Possession Register of the Structures/Shopping cum Residential units of the Aahar Kendra as sought by Government of India, vide their L. No. F.NO.8-68/2018-FC dt. 12.10.2021. It is stated by the user agency that after scrutiny of the old records, it was ascertained that the building used as Aahar Kendra has been in use prior to the FC Act in 1980. The old records pertain to the period of 1960's. Hence, it took a considerable time to trace the records. From records it ascertained that the building at present used as Aahar Kendra was previously allotted as republic store since 1965. The compliance had been sent to your good office vide this office L.No.22320 dt.03.11.2022. But the soft copy of the letter was uploaded on 23.05.2023. The user agency has stated that inadvertently the documents were missed for which it was delayed in uploading the compliance. The copy of

the records of annexure-I of the compliance dt. 03.11.2022 is resubmitted herewith and enclosed as **Annexure-I**.

Observation (ii):- Similar justification regarding violation has already been provided earlier by the state which was not accepted by the ministry. Therefore, the information as sought by the Ministry's in its letter dt. 12.10.2021 be submitted at an earliest so that the next action may be taken by the Ministry without further delay which will also caused for applicability of revision rate of the NPV as per the Ministry's letter dated 06.01.2022 read with letter dated 22.03.2022.

Compliance: - The compliance to the Stage-I observations have been submitted from this office vide Letter No.11829 dt. 19. 06. 2020 to MoEF& CC, GoI.

No violation in respect of functioning of Aahar Kendra has been done. It is a pretty old building of the Paradip Port trust, constructed during 1960's. The building has been constructed long back of enactment of forest (conservation) Act, 1980. The said building existed prior to 1980 and has been renewed many times since 1965 and a copy of the same duly attested by the Senior Manager, IOB, Paradip is enclosed as **Annexure-I Series**.

Further, it is to inform that the Aahar Kendra is an outlet for supply of food to the poor and needy people at a nominal rate of Rs 5/- in urban area at places of public congregation such as near Hospital, Bus Stand, Railway Station, Court etc under a social welfare scheme "Aahar Programme" launched by Govt. of Odisha and the beneficiaries of this programme are mostly patients, attendant of patients, construction workers, labourers, rickshaw pullers, auto drivers, street children, rag pickers etc.

Observation (iii):- In case reply is not received within 15 days the proposal will be processed for rejected summarily for non-compliance of the Stage-I within five years as per guidelines.

The Stage-I compliance as well as compliances to the observations of MoEF& CC, GoI have been submitted time to time as per requirement.

In view of the facts stated above, it is requested to consider the diversion of 75.635 ha of Forest land for Development of Outer harbour, Inner harbour including Western Dock & Mechanization of existing operational berth by M/s Paradip Port Trust, Odisha and accordingly Stage-II/Final approval order may please be accorded.

Sir,

Inviting reference to the above the point-wise clarifications & compliances are as under;

1. It is to submit that earlier clarifications on the use of 'Aahar Kendra' under a social welfare scheme of the Govt. was not accepted though the same building was utilized since long. Subsequently, the old records were checked and from the official register it was ascertained that the said building has been in use prior to the FC Act in 1980. Since the records pertain to the period of 1960's, tracing out these old records took considerable time. As regards not uploading the reply letter dated 03.11.2022 with the enclosures (Annexure-I Series), it is to submit that the same has been inadvertently missed out. The forwarding letter along with the enclosures (Annexure-I Series) are resubmitted for kind onward transmission to MoEF & CC, Govt. of India.
2. (a) In the earlier reply vide No.FE-DIV- FLD-0098-2021-10F(Cons)150/2018-12000/F&E, dated 13.07.2021(with PPCF letter dated 01.06.2021 & Annexures) it was informed by F & E Dept., GOO that as regards the issue of compliance to condition No-(iv) of Stage -I Clearance, the "Aahar Kendra" in question is under a Govt. social welfare scheme as an outlet to provide food to poor and needy people, also indicating that the above Aahar Kendra stands on the land that has already been in use by Paradip Port during its beginning period in 1970's.

(b) In the reply letter vide dated vide No. 22320/9F(IND)-371/2018, dated 03.11.2022 (with Annexure-I Series), it has been brought out that the possession registers of the structures/ shopping cum Residential units of the relevant area has been traced out which establishes that the building now being used as Aahar Kendra is on a building which existed prior to 1980. As reveled from the old building resister this was allotted as 'Republic Stores' since 1965 which has been renewed many a times. Copies of the old records were enclosed and it was requested that considering above background facts, the Aahar Kendra need not be considered as a violation under FC Act and accordingly Stage-II Clearance letter may be accorded.

In view of the above, it is requested that the reply letter along with the enclosures (Annexure-I Series) which are now resubmitted may please be processed for onward transmission to MoEF & CC, Govt. of India.

In view of the aforesaid background, the Forest Diversion proposal may please be processed further for onward transmission to MoEF&CC, Govt. of India for according Stage-II approval.

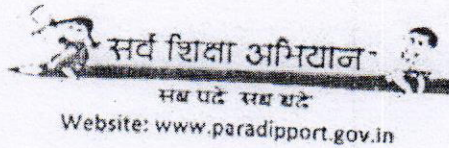
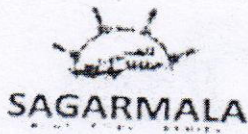
