

	<p>The Forest Divisional Officer, Paloncha, has requested the PCCF, vide RC.No: 3284/1990/P5, dt: 01.06.2024 to provide Authentication map and Annexure I & II of the Rasannagudem -III CA land to prepare and to submit the Notification proposal with relevant documents to the District Forest Officer, Bhadradi Kothagudem within a week.</p> <p>The report received from FDO, paloncha has been forwarded to IT wing O/o PCCF for verification of annexures.</p> <p>The Notification of CA land may take certain time to publish in the gazette. However, the process has been initiated by the forest department and the MOEF&CC is requested to impose the condition in Stage-I approval for Notification of 42.96 Ha of CA NFL land , so that the forest department will submit the Notification of 42.96 Ha as RF/PF along with Compliance for grant of Stage-II.</p>
